*Citizens' Vigil outside the Ministry of  
Health in Paris every Friday*

It is clear that in France and elsewhere, **the health consequences of ionizing radiation** emanating from industrial and military nuclear activities **are being covered up**. The International Atomic Energy Agency (IAEA) and other UN international agencies such as the World Health Organization (WHO) are involved in this cover-up.

However, it is the WHO's mission to ensure that people attain the highest possible level of health. That is why we are challenging **the French Ministry of Health, jointly responsibly for the cover up**, because it represents our country within this particular international institution.

The objective of the collective "IndependentWHO - Health and Nuclear Power" is to get WHO to respect its constitution and fulfil its responsibilities independently on matters relating to exposure to radioactive substances and its consequences for health

As regards the health consequences of nuclear power, the WHO relies on the IAEA to assess them. In this way, the official toll for the Chernobyl disaster is still given as fifty deaths and 4000 cases of thyroid cancer in children – whom it describes as “effectively treated.” These figures need to be set against the figures contained in the study conducted by the scientist Alexei Yablokov; this study was published by the New York Academy of Sciences in 2009. It estimates the number of deaths caused by Chernobyl between 1986 and 2005 to be in the region of 985,000.

Our country is especially responsible because it is the most nuclearised in the world. We remember how the French government lied to its people while the cloud from Chernobyl passed over its territory. Today, **justice has still not been delivered to the victims**, including those suffering from thyroid disorders. The victims of French nuclear tests are even older, and are also waiting for recognition and compensation.
